## Thomas Kohlbauer takes over as new COO of the E.G.O.-Group

The 52-year-old Kohlbauer began his career in the German Armed Forces, where he gained his first leadership experience as a squadron captain while studying mechanical engineering with a focus on vehicle construction in Munich. Building on this, he took a Master's degree in Business Administration (MBA) in Switzerland and the USA, which he completed at his new place of work, BROSE Fahrzeugteile SE & Co. KG. Kohlbauer held responsible positions in Quality and Sales before becoming managing director of the Brose locations in Japan and England. In 2015 Kohlbauer moved to MAHLE, where he headed the Mechatronics Division with approximately 4,500 employees.

"I am very pleased that the management of the E.G.O.-Group is now complete," says Dirk Schallock, who has been heading the fortunes of the world-renowned supplier to household appliance manufacturers since January 1, 2019. "In Thomas Kohlbauer we have found the ideal candidate, in our view. He not only has a sound technical background, but also the necessary management know-how and leadership experience — and in an international environment as well."

Kohlbauer will be responsible for the E.G.O.-Group's production and supply chain divisions, which include the internationally active Industrial Engineering, Supply Chain Management and Production Technology Center, as well as 12 production sites combined in one production network.
